**European Prize for young researchers in the field of
neurodegenerative pathologies leading to dementia**

“Fondazione Gino Galletti Neuroscience Prize 2017”

Regulations

Art. 1. “Fondazione Gino Galletti”, hereinafter referred to as the ‘Foundation’, announces a competition for a prize of € 10.000,00 (ten thousand/00), to be awarded to a young European Union researcher who is the main author of a scientific publication on the subject of neurodegenerative pathologies leading to dementia.

Art. 2. The competition is open to citizens of Member States of the European Union* under the age of 40 years on **31st December 2016**. Application letter should be addressed to the scientific coordinator of the Foundation **in person** or **by registered mail** or **e-mail with receipt request**.

The following documents must be provided:

1. Application letter with name and surname of the applicant, date and place of birth, official address and e-mail for correspondence.
2. A CV with a full list of publications (with the authorization to use personal data for the scope of the competition).
3. Copy (printed or electronic) of the paper the applicant wishes to submit to the evaluation of the Committee of judges. Paper must have been published or accepted for publication (with proof) in the period 1st January 2015 - 31st December 2016.
4. Proof-of-age (copy of passport or ID).

"Participation in the Fondazione Gino Galletti Neuroscience Prize 2017" should be indicated on the envelope or in the e-mail subject.

All personal data will be treated in accordance with the Italian law on privacy (D.lgs. 196/03, “Codice in materia di protezione dei dati personali”, and subsequent amendments), and only to the extent necessary for participation in the competition and to allow the application to be evaluated by the Committee of judges.

Deadline for the application is **30th June 2017, 23:59 CET**. Applications received after the deadline, even if posted before, will not be accepted.

Art. 3. The Committee of judges is composed of the Foundation Scientific Committee, which may request the support of other experts. Committee decisions are final. In particular the Committee may decide to split the prize *ex aequo* between two or more researchers or not to award the prize if no publication is deemed of sufficient interest.

Art. 4. The Foundation Scientific Coordinator will inform the winner by registered mail or e-mail with receipt request to the address indicated on the application letter. It is the applicant's responsibility to notify any change of address.

Art. 5. The Prize will be awarded to the winner by the Foundation Chairman or his representative on the occasion of a scientific meeting to be held in Bologna. At this meeting, the winner shall make a public presentation of the results of his/her research. The date of the meeting will be notified to the winner at his/her correspondence address.

Art. 6. The Foundation Board and its Scientific Committee have approved these regulations. The present regulations may be amended as required. A copy of the regulations and any amendments to the same can be found on the Foundation website:
